When we send your Tax Return to you for approval, you will receive an e-mail with the subject "Tax Return for signing - Documents for signature from Kreston Reeves LLP"

If you open the email, the message will look something like this:

Click on the orange box "Secure Portal Access".



The "Geolocation" box is included as one of the "items" for review.


